

GENERAL CONDITIONS OF BASIC-FIT GIVEAWAYS AND CONTESTS ON SOCIAL MEDIA

By participating in a Basic-Fit giveaway or contest, you agree to the following general conditions:

1. ELIGIBILITY

- 1.1. To be eligible to participate and win a Basic-Fit giveaway or contest you must (i) be over 16 years old (ii) have a social media account on the platform where the contest/giveaway is held (iii) and live in one of the countries where Basic-Fit operates.
- 1.2. The participation is limited to one participation per social media account.

2. HOW TO PARTICIPATE

- 2.1. To enter the giveaway or contest you must follow the instructions in the social media post or landing page. Entries submitted by any other means will not be accepted, only entries submitted through the official method of entry will be accepted.
- 2.2. Only entries to enter the giveaway or contest that are made within the effective dates of the giveaway or contest indicated in the social media post or landing page will be accepted.
- 2.3. Giveaway winners will be selected randomly (unless otherwise noted in the social media post or landing page) from among all eligible entries and will be announced by direct message to the social media account they used to enter the giveaway.
- 2.4. The winners of the contests will be those defined as winners according to the description of the contest on the social media post or landing page.
- 2.5. Winners will be announced on the Basic-Fit social media account. The winners will be invited to send a private message to our account to claim their prize.
- 2.6. Participants must comply with the terms, policies and guidelines of the social media platform.
- 2.7. By participating, you confirm that you have the rights to any submitted content.
- 2.8. By entering the giveaway or contest, you confirm that any third party that you tag in the contest or giveaway on social media have provided their consent for being tagged in such post for the purposes of this giveaway or contest.

3. THE PRIZE

- 3.1. Participation in the giveaway and/or contest is strictly personal and nominative. The prize is non-transferable and not cash refundable.
- 3.2. By participating in the giveaway or contest, you agree to these terms and conditions in their entirety. Failure to comply with the conditions of participation set out in these general conditions will result in the nullity of the participation.
- 3.3. By becoming a Basic-Fit member (even due to a giveaway or contest) you acknowledge and accept our Terms and Conditions and House Rules (available on our website).

4. RIGHTS OF BASIC-FIT

- 4.1. Basic-Fit has the final decision to qualify an entry as an eligible entry to participate in the giveaway or contest based on the above criteria.
- 4.2. Basic-Fit reserves the right to delete any submissions that are rude, defamatory, insulting, inappropriate, racist, sexist, homophobic or otherwise offensive, discriminatory or inappropriate.
- 4.3. Basic-Fit reserves the right to cancel the attribution of the prize to any person who uses it in an abusive manner, breaches any of these general conditions or violates any law or regulation.
- 4.4. Basic-Fit is not responsible and shall not be held liable for any change in the prize made by third parties.
- 4.5. The winners may be required to provide proof of identity and any documentation as reasonably required to validate their eligibility to claim the prize and their proof of age. If a winner is found to be ineligible or does not respond to Basic-Fit's notification of winning or provide any information requested within such notification of winning to receive the prize, Basic-Fit reserves the right to require the return of the prize, to void it or to award the prize to an alternative eligible entrant through a further random prize draw of all other eligible entrants, as the case may be.
- 4.6. Basic-Fit will use the personal details supplied for the giveaway or contest and for no other purpose. This information may be shared with Basic-Fit's agents and affiliates, such as where it is necessary in order to conduct the giveaway or contest, including for the prize to be delivered to the winners. If for any reason any aspect of this giveaway or contest is not capable of running as planned, Basic-Fit may in its sole discretion cancel, terminate, modify or suspend the giveaway or contest or the prize, or invalidate any affected submissions. Basic-Fit shall use all reasonable endeavors to notify the winners of any change of plan.

5. LIABILITY AND JURISDICTION

- 5.1. Basic-Fit denies any liability in the event of a malfunction preventing access and/or the smooth running of the giveaway or contest.
- 5.2. The use of robots or any other similar automated processes allowing you to participate in the giveaway or contest is prohibited; violation of this rule resulting in a definitive elimination.
- 5.3. Basic-Fit may cancel all or part of the giveaway or contest if it appears that fraud is being committed.
- 5.4. You admit without reservation that the simple fact of participating in a giveaway or contest subjects you to French law.
- 5.5. Every participant has the right to have recourse, free of charge, to a consumer mediator with a view to the amicable resolution of any potential dispute with the organizer.
